## Memorandum of Understanding

### *“Produced in Chenango” Label Program*

By participating in the “Produced in Chenango” label program, the producer hereby agrees to the following:

- The label is being affixed to a product that is either grown, raised, or otherwise produced—from scratch—in Chenango County, NY.
- They have exclusive rights to produce and sell the product that the label is being affixed to
- They are conducting business transactions in a way that is considered legal and legitimate in accordance with the laws of the State of New York and the United States of America.
- They are charging sales tax on all items that are subject to NYS and local sales tax.
- All local laws are being followed, and all necessary licenses and permits have been acquired.
- Any required licenses and permits are being kept up to date and in good standing.
- If the product requires USDA or NYS Ag & Markets inspection, that inspection has taken place and the product has passed that inspection.
- The producer has provided all appropriate contact information (name, address, phone number, email address) to the CCADC for contact purposes, and for promotion of the business / farm on the CCADC website as a participant in the program.

#### **Additionally:**

The undersigned hereby releases The Chenango County Agriculture Development Council, its Committee Members, and any related or subsidiary organizations, its agents, officers, and employees (hereby known as the CCADC et al) from all responsibility and any liability for any injuries, illness, and/or loss which may result from or arise out of, or be connected with the sale of the product that the “Produced in Chenango” label has been affixed to.

I, the producer, accept all responsibility and any liability from said injuries, illness, and/or loss which may result from or arise out of the sale or consumption of my products bearing the “Produced in Chenango” labels.

I understand and agree that this Memorandum of Understanding is binding on me and my heirs, executors, administrators, personal representatives, and next of kin. My signature denotes my understanding of and agreement with this statement and its implications.

I agree that if I am found in violation of any of the items agreed upon by signing this document, I will be removed from the CCADC “Produced in Chenango” website, and that I will be expected to return any excess labels to the CCADC.

I agree that this document shall be interpreted and governed by the laws of the State of New York.

I agree that if any provision of this document shall for any reason be held invalid or unenforceable, such invalidity or unenforceability shall not affect any other provision of this document.
